## Foreman Report for March/April, 2021

- With the nicer weather Cole and Mitchell have been out on the graders.
- Jerry has returned to work and has been out on the grader.
- With road bans on Shayne and Lanny have been working on their trailers, installing rubber belting to protect the trailers better and we put grader blades in front of each axle to protect the brake pots and air lines from rocks.
- Shayne and Lanny started moving the pit run, using the tandems, from Marvin Schmidt's to the Old 6 stockpile location prior to the snow storm.
- Kelly has been working on the equipment hydraulic hoses on the excavator and various repairs on the mowers, getting them ready for spring/summer.
- The motor for the International semi is complete at Continental so Kelly and Garth have been putting it back together. They are replacing the hoses, water pump and turbo at the same time.
- The New Holland TM155 tractor sold on McDougall Auctions on April 12<sup>th</sup> with a closing price of \$38,000.00. There were a lot of inquiries regarding the tractor within the last few hours of it being posted.
- Shop work and days off during the snow storms.
- Ron Olson was inquiring about the pit run that he has stockpiled, we will be hauling it to the Old 6 stockpile location once road bans are off.
- Grader operators have informed me that there are lots of people passing them while their lights are flashing at excessive speeds. It may be beneficial to remind ratepayers to slow down to 60 km/h when passing equipment with their lights flashing.
- We will plan to clay cap a section of Grid 641, north of Craven, at the end of June/beginning of July, depending on weather.
- I have received inquiries from students regarding us hiring a summer student.

## Follow-up from March 15th Meeting:

- Contacted Eric Johnson with Miller Thomson Law Office to let him know that we are disappointed in the services that the firm is providing since Ahmed Malik's departure. He informed me that he will supervise our file closer and provide updates to us on a more regular basis.
- Council questioned how many people are affected by the outstanding taxes on the February, 2021 financial statement 53 individuals/families are affected with the majority being residential taxes outstanding.
- A letter was sent to Yancoal Canada Resources Co. Ltd., to the attention of Chairman Victor Tian, regarding their well decommissioning and an update will be provided at the April meeting.
- Legal counsel was given direction to attempt personal service on Mr. Klock to have his horses removed from his property in High Country Estates and an update will be provided at the April meeting.
- The Lease of Municipal Road was forwarded to the Rock Ridge Condominium for their review and a formal response has not been received to date.
- Bylaw 8-2020, being a bylaw to amend the Zoning Bylaw was amended to incorporate further restrictions and will be reviewed at the April meeting.
- Inquiry to the RM of Touchwood No. 248 regarding what they pay for pit run \$3.00/cubic yard and they have various pits located throughout the municipality.
- Finn Construction and Morsky Construction were contacted to clarify their roto-mixing tenders and determine what equipment would be used. After clarification council agreed to hiring Finn Construction.

## Additional work completed:

- The annual audit was conducted on March 24<sup>th</sup> and 25<sup>th</sup> by Dudley & Company and was a total of 18 hours.
- The re-valuation assessment roll was completed and notices were sent out on March 26<sup>th</sup> with the appeal period closing on May 26<sup>th</sup>.
- I was on vacation from March 31<sup>st</sup> until April 7<sup>th</sup>, inclusive.

## Messages of Concern/Gratitude

- Email received on March 21<sup>st</sup> regarding Old Hwy. No. 6 needing bladed as it was not done since October. The message was passed onto the foreman and the road was bladed on March 26<sup>th</sup>.

- Tree programs for Urban's Regina dog park along the Wascana Creek banks.

  - Channel from Buffalo Pound
  - How it affects Upper Qu'Appelle
  - Last Mountain Lake will be involved.

- President's Report
  - Ag is an important driver
  - Cattle and hog backlogs
  - AgriStability is not enough lobbying to restore to 2013 levels.
  - Food supply
  - Carbon offset 39 priority issues
  - COVID has slowed down lobbying efforts with grocery stores shelves being empty in big centres it has brought ag to the forefront.
  - Look into supply chain problems due to COVID.
- Prioritize some of the issues to get better coverage and have the capacity to handle lots of issues.
- Direct seeding may not be considered for the carbon offset program because if there is more than 40% already being used then it would be considered a normal practice.
- Beyond meat and items such as almond milk and oat should be re-labelled/rebranded to not be misleading (Beyond meat should not include the term meat).
- Youth Leadership mentorship program attended an Ag meeting in Ottawa.
- 137 out of 296 RM are members of APAS, which includes 15,000 farms and ranches.
- Rural Connectivity Task Force
  - Funding should be based on area not just population.
  - Smaller companies come into play.
  - Starlink will be moving in.
  - o Trouble with signals along provincial borders (20 miles wide).
  - Rural Manitoba has internet and cell troubles.
  - Fibre optics can be hung with power lines.
