1.0 Time and Place

- 1.1 Tenders will be submitted to the Rural Municipality of Longlaketon #219 by May 9, 2025 at 4:30 p.m. local time. Tenders may be submitted by the following means:
- Sealed with the words “Used Pay Loader Tender” to the Rural Municipality of Longlaketon #219 Box 100 Earl Grey, Sk. S0G 1J0
 - Emailed with the subject line stating “Used Pay Loader Tender” to rm219@sasktel.net
- 1.2 Tenders will be opened at the Regular Meeting of Council on May 13, 2025 at approximately 1:00 p.m. local time.

2.0 Tender Acceptance

- 2.1 The Municipality reserves the right to refuse to accept any or all tenders, and the highest tender will not necessarily be accepted.
- 2.2 Without limiting the generality of the foregoing, any tender may be rejected which is incomplete, obscure or irregular.
- 2.3 The Municipality reserves the right to cancel the acceptance of any tender at any time before payment has been made.

3.0 Late Tenders

- 3.1 Tenders received after the time and date specified in Clause one (1) of the Instruction to Purchasers will not be considered.

4.0 Validity of Tenders

- 4.1 A purchaser may, without prejudice to himself, withdraw his tender at any time up to within two (2) hours of the time specified in Clause one (1) of the Instruction to Purchasers.

5.0 Tender Limitations

- 5.1 Oral and telephone tenders will not be considered.
- 5.2 Oral and telephone modifications to submitted tenders will not be considered.

6.0 Equipment Tender

- 6.1 The Rural Municipality of Longlaketon #219 is offering for sale by tender:
- a) 1975 75B Clark Michigan Pay Loader as is where is – the bidder agrees that the Rural Municipality of Longlaketon #219 has made no agreement, representation or warranty as to the condition of the equipment.

7.0 Tender Requirements

7.1 The successful purchaser agrees to the following:

- a) Provide payment in full within 10 days of successful tender acceptance
- b) Be responsible for pick-up/transport of the pay loader
- c) Pay all applicable taxes – not to be included as part of the tender bid
- d) Other requirements as Council may deem necessary upon tender acceptance
