Administration Report for May/June, 2023

Follow-up from the May 9th Meeting:

- An application was submitted to the RIRG program for the replacement of the Little Church Road Bridge
- The pictures of the load of garbage that was dumped at the South Transfer Station were posted on Facebook. The guys cleaned it up, with the help of Blair and Tyler Herman and they found documents with names on them that were given to the CO's to perform an investigation.
- The 1975 John Deere scraper was posted for tender, with tenders to be received by July 7th.
- I contacted Midwest Surveys to obtain a price for surveying the road allowance being East of the NE Qtr. of Sec. 24, Twp. 21, Rge. 20, W2.
- I let Brett Tallentire know that his quote to construct a fence on the NE Qtr. of Sec. 24, Twp. 25, Rge. 19, W2 was accepted and that we would like the work done late summer/early fall.
- Aaron Merkel was granted a development permit to construct an accessory building within the side yard setback distance on Lot 2, Block 101, Plan 88R18887.
- I sent letters to neighbouring property owners of Lot 3, Block B, Plan 101900843 to obtain their concerns/comments on an oversized accessory building. This will be discussed at this meeting.
- I informed Brian & Darcie Cooper and Kevin & Jennifer Huber that council granted pre-approval for subdividing their residential yard sites.
- I informed Campion Hein that council did not grant pre-approval for her multiparcel residential subdivision.
- I contacted SK Liquor & Gaming to inquire why the RM has to approve Community Event Licenses. They have to be approved by the municipality so that SK Liquor & Gaming is not granting approval to an event that is taking place where it is not appropriate or contravenes the RM's rules. There is no liability for the RM by issuing the letter of approval.
- The bridge information that Garry submitted to council was passed onto the SARM Bridge Department for their input, I have not received a response back yet.

Other Business Conducted/Updates:

- An agriculture accessory building permit application was taken out for the SW Qtr. of Sec. 07, Twp. 21, Rge. 20, W2.
- A deck building permit application was taken out for Lot 3, Block A, Plan 102003141.
